2. Advisor of the FBCCI Safety Council will act as the Member Secretary of the Committee. Safety Council of FBCCI will provide necessary secretarial support.

3. The Terms of Reference of the Committee are as follows:

- i. The committee will make critical discussions in the time of crisis specially natural calamity, fire incidence, IT security or any other urgent situations to act systematically and speedily.
- ii. The committee will identify potential risks and vulnerabilities to the organization and develop crisis management plans, protocols and procedures, etc.
- iii. The committee will develop an emergency communication strategy to ensure timely dissemination of information to its members and stakeholders.
- iv. In the case of an event of a calamity /disaster, the committee will make it a priority to visit the disaster affected area (like industry/ business center/ markets) to convey sympathy to the affected people / community from FBCCI.
- v. The committee will oversee overall crisis management program and will provide training on crisis management and conduct drills to ensure employees preparedness.
- vi. The committee may co-opt any competent person as the member of the committee.
- vii. Any other related matters assigned by the Board.

This order will be effective immediately.
